Terms and Conditions of your contract with E.ON

1. Contract

This contract is between you and E.ON Energy Ltd (E.ON/we/us) for the supply of electricity and/or mains gas. These terms and conditions and the contract confirmation letter setting out prices are the complete contract between you and E.ON Energy Ltd.

This contract is governed by the laws of England and Wales for supply in England and Wales and by the laws of Scotland for the supply in Scotland. Nothing in it affects your statutory rights. We reserve and maintain all our rights set out in Electricity and Gas legislation and our licence.

For your electricity supply, the connection terms with the local Distributor are incorporated into this contract, a copy of which is available on request.

If you are agreeing this contract for a limited company, partnership or other organisation, you confirm that you have the necessary authority. If you are a sole trader in England or Wales you confirm that you are over the age of 18 and if trading in Scotland that you are over the age of 16.

If you are a partnership or other organisation you and the other partners or officers will be jointly and severally liable under this contract, You may not assign this contract without our consent.

You will be entitled to increase the number of properties built on the site at any time. Any other changes to the specified plot(s) will be subject to prior written agreement.

2. Ending the contract

This contract will run from the day the meter(s) is/are connected on the agreed plot(s) and will continue until it is terminated in line with these Terms and Conditions or the plot(s) covered by the contract become occupied. If you breach the terms of this contract, we may end it immediately and supply you on alternative terms.

3. Price and Payment Terms

We may change the prices or other terms of this contract. You must tell us if you then wish to cancel the contract and for the change not to take effect.

You will receive bills from us for your gas and electricity usage. We may estimate your usage. A meter reading is taken as proof of your gas and electricity usage unless your meter is found to be faulty. Either of us can arrange for the meter to be tested, but if you ask for a test and the meter is found to be accurate, you will have to pay for the test.

Please pay us in the way that we have agreed. If you pay by cash, payment is due promptly on receipt of the bill. Please tell us immediately if you have difficulty paying. We reserve our rights to disconnect the supply. We may charge you our costs.

Where the expression 'you' means more than one person each person will be jointly and severally liable to us for any money owed. This means that we will be entitled to claim part of the money owed from you all or the whole sum from any one of you.

We may charge you our costs if:

- you damage our equipment or equipment provided by the network operator; or
- you fail to take reasonable steps to protect our equipment or equipment provided by the network operator; or
- you request us or our agents to attend at your home unnecessarily.

4. Access

You must allow access to your gas, electricity network operator or any person authorised by us. This may be to install or work on equipment, to read or inspect the meter(s), cut off supply or for a gas or electrical emergency. In a gas emergency, we or the network operator may require you to stop using gas.

5. Changing your gas or electricity supply

You must contact us and secure our agreement if you wish to install generating equipment or modify your gas or electricity connection. You will have to pay the costs.

You must tell us if you appoint your own metering agent or change use of the premises to business purposes; we will provide an alternative contract.

6. Occupier moving in

When a new occupier moves in we will need at least 48 hours notice, or we will continue to charge you until you tell us they have moved in, or we next read the meter or the new occupier takes our services.

7. Service Availability

Your gas and electricity supply may be interrupted or of lower quality due to circumstances outside our reasonable control.

8. Liability

We, and the gas or electricity operator, are liable for death or personal injury caused by our negligence. We are responsible for any loss which is a foreseeable consequence of our negligence and is caused by us breaching the terms of this contract. We are not liable for any other loss, including those caused by an event or circumstances beyond our reasonable control, or for any business losses.

9. Special conditions

You will use the 'E.ON pack', and other appropriate information agreed with the New Business Development Housebuild Team, within your own promotional materials and any house-buyers manuals, or similar documents, provided by you to any prospective or actual buyer of any property which you build on the site.

You will ensure that your staff only use documents as may be supplied by us.

Upon termination of this contract, you will cease to represent yourself as associated with E.ON Energy Ltd and you will return all materials and documents supplied by us.

You will not market or cross-sell any other similar products and/or services for the duration of this contract
